## Dear Friends,

This past season has been one of celebration and forward momentum for the Princeton Symphony Orchestra. At the midpoint of a multi-year endeavor to reimagine the future of the PSO and establish a sound financial foundation for growth, we exceeded our benchmarks and brought world-class musical experiences to more people than ever before. Your generous investments have fueled three major initiatives:

### Building Back Audiences Post COVID

An engaged and enthusiastic audience makes a live concert electric—and it is the key to long-term financial stability. The PSO has implemented several strategies to bolster our audience after the pandemic, particularly for our Saturday performances at Richardson Auditorium. We invested in targeted ticket subsidy programs, expanded marketing efforts, and increased social opportunities connected to these concerts. The 2024-25 season marked the first time ticket sales alone exceeded expenses for these additional performances.

### Solidifying the Future of PSO BRAVO! Programs

Because these critical education programs are offered to participants completely free of charge, their growth depends entirely on contributions. We were thrilled to receive a \$500,000 gift to begin an endowment fund specifically to ensure PSO BRAVO! can continue to provide music-centered educational programs to over 10,000 area students each season.

### Creating a Destination Festival

Since the 2021 merger, the Princeton Festival has become an iconic summertime celebration. After two tent expansions, we continue to see sold-out performances! With superstar artists, the Princeton Festival regularly draws new audiences to town for extraordinary music.

This report shows how donors like you strengthened the fiscal foundation for all of the PSO's community offerings last season. Just think of all we can do together with your continued support! Thank you for ensuring the performing arts continue to thrive in Central Jersey.

# Finances


In the 2024-25 season, the Princeton Symphony Orchestra continued stable growth, with ticket sales increasing by 32% over the previous fiscal year, rising from \$757,663 to \$999,171. Total earned revenue, including interest from our delayed Employee Retention Tax Credit (ERTC) payment, reached \$1,266,278, an increase of 47% over the prior fiscal year.

Support from our generous donor family provided \$3,320,835 in contributed revenue, up from \$2,686,045 the previous year.

We continue to increase program offerings in response to community desire. This expansion, coupled with high inflation, led to increased investment in our programs, education and community engagement efforts, and administrative infrastructure.


## Revenue




## Attendance
